ELIGIBILITY REQUIREMENTS: All A-8 members of the Wisconsin PGA and registered associates are considered WAGPA members and may participate as long as they are in good standing with the PGA. Any suspended member or associate may not participate in events. **A terminated associate MAY NO LONGER join WAGPA as a pre-associate after their 8 years are up, they must re-register with the PGA of America.**

Pre-associate applicants must be employed in an eligible employment classification in the Wisconsin Section. Pre-associates are eligible to join WAGPA for a **MAXIMUM OF TWO YEARS** prior to registering into the PGA PGM program. A pre-associate may apply for an extension after two years to the WPGA Tournament Policy Board.

RESPONSIBILITY OF APPLICANT: The applicant hereby agrees to adhere to, and be bound by the Code of Ethics as set forth in the Constitution of the National PGA, the by-laws of the Wisconsin Section PGA and the tournament rules as established by the Tournament Policy Board. The applicant further agrees to conduct himself/herself at all times, in a manner that will bring credit to him/herself and to the professionals of the Wisconsin PGA.

TOURNAMENT LIMITATIONS: Approved player's status will permit the associate to participate in all tournaments co-sponsored by the Wisconsin PGA, excluding those events which are for WPGA members only. Please keep in mind some tournaments do have priority registration for PGA members and associates (Classics & Pro-Ams).

PLEASE NOTE THIS MEMBERSHIP AS A PRE-ASSOCIATE IN THE WISCONSIN ASSISTANT GOLF PROFESSIONALS' ASSOCIATION (WAGPA) DOES NOT REGISTER YOU WITH THE PGA OF AMERICA OR GIVE YOU STATUS WITH THE NATIONAL ORGANIZATION.

MEMBERSHIP REVOCATION: Applicant's membership privileges shall be subject to revocation if during the period covered by the card applicant's status shall change so that he/she no longer meets the eligibility requirements. Any violation of the applicant's responsibilities described above will also be grounds for revocation of applicant's card and playing privileges connected therewith.
