Wisconsin PGA Membership Meeting Minutes Monday, October 25, 2021 Embassy Suites - Brookfield, Wisconsin

Meeting called to order at 12:02 p.m.

Minutes from the March 2020 meeting were approved after a motion from Jim Gaugert and a second from John Wallrich.

Mike Warren, President of the WGSA provided an update to the membership on the activities of the WGSA. He announced that the association held elections for officers that will take over in spring of 2022. Jim Gaugert will be president. Dan Hoffman will be VP and Jeremy Lupinek will be secretary.

Elections for three positions at-large on the WPGA board were conducted. The election was overseen by Mark Voeller, Secretary of the WPGA. Mike O'Reilly, Matt Taken and Bill Peters all presented their qualifications and desires to be elected. All elected by acclimation and subsequently sworn in as directors for a three-year term. Dave Kemnitz was preciously elected to fill the vacant term of Northwest District Director.

Ed Woronicz from Fairways to Heaven provided an overview of the services their company provides in international travel.

Danny Rainbow provided an update on the 2023 US Senior Open to be conducted at SentryWorld.

Report of Mark Voeller, PGA – WPGA Secretary

Mr. Voeller asked for a moment of silence for Steve Scheel and Steve Jahimiak. Mark mentioned Mike Muranyi being inducted into the Wisconsin State Golf Hall of Fame. He then introduced quarter century members, new members and those new to the section. He provided an update on the number of members in the section. Mark then introduced half century member, Gene Frank to receive his award. Gene provided some great stories from his playing days. Mark closed by encouraging members to get a golf license plate and support the foundation and the marketing efforts of the WPGA.

Report of Mike O'Reilly, PGA - WPGA Vice President

Mr. O'Reilly provided the updated WPGA financials and stated that everything was a good place for the year and the future.

Report of Jeff Ellingson-WPGA President

Mr. Ellingson mentioned this was his last meeting as president. He discussed the marketing campaign and showed some of the short clip videos. He shared the intention to highlight employment and indoor golf this winter. He congratulated the section members for all their efforts on the Ryder Cup.

Report of Rob Elliott - Incoming District 6 Director

Rob began his report with a Ryder Cup video. He then provided some highlights of the event. Mr. Elliott then provided an update on the various items the PGA is working on including an affiliate classification, Frisco HQ. Deferred Compensation, etc.

Report of Joe Stadler, PGA - WPGA Executive Director

Mr. Stadler provided an update on the Ryder Cup. A video was show highlighting PGA HOPE. Mr. Stadler thanked the WPGA's largest sponsors and the Foundation's largest sponsors.

WPGA Junior Foundation - Joe Stadler, PGA - WPGA Junior Foundation President

Mr. Stadler thanked Ed Elsner for his four years as president of the WPGA Junior Foundation. Stadler then briefly recapped the main pillars of the foundation, junior tournaments, DCP, PGA Junior League, PGA HOPE and scholarships. He thanked all the hosts of the events. Mr. Stadler thanked everyone that donated to the fundraiser. The event/auction netted over \$55,000. A video was shown on the event.

Report of the Committees:

Assistants: Shaun Finley encouraged all eligible assistants to apply for the IronWorks Scholarship. He informed everyone that we had 18 PAT passes out of 90 attempts. He asked anyone interested in joining the committee to reach out.

Tournament Policy Board: Matt Taken thanked all the hosts, sponsors and volunteers and mentioned we utilize over 110 facilities. He asked everyone to make sure to thank you sponsors. He congratulated our 2022 section championships. Michael Crowley qualified for the Senior PGA. He then thanked Vince Suter/Suter Ward Group at Morgan Stanley. Matt mentioned the two site state open, the senior/junior and the stableford. Mr. Taken also congratulated Mia Seeman for winning the Women's State Open and using the exemption into the Wisconsin State Open.

Education: Danny Rainbow mentioned the MSR cycle ending on June 15, 2021. The new cycle will begin and be a 3-year cycle. He encouraged everyone to get their credits and not wait until the last minute. The committee is working on a virtual series for the Jan-March time frame. The spring teaching seminar will be planned as in an in-person event. Lastly, he mentioned the Golf Operations workshop scheduled for Tuckaway CC in early December.

Membership: Mark Voeller started by showing a video highlighting Hanc Spivey. Mark encouraged everyone to get involved with the game and the association. He highlighted the upcoming PGA National meeting and reminded everyone they are welcome to attend.

Employment: Brian Bishop thanked Tim Marks for his years of service and dedication to the PGA and in particular the members of the WPGA. Tim Marks provided an update on the employment services department at the PGA. He discussed compensation, work-life balance, recruiting and execusearch. Tim closed by thanking everyone for their support over the years.

Player Development: Scott Walecki mentioned that he is new to the position of chair. He said he wants to focus on best practices and more on adult programming. Erika Pirkl provided an update on DCP. Frank Chieppa highlighted 2021 in PGA Junior League. He provided an update on 2022.

Special Awards: Mr. Weitz provided the process for how award winners are selected. He mentioned that the 2021 winners will be honored later that evening at Westmoor CC. He encouraged the membership to nominate their peers.

Nelthorpe: Mr. Weitz thanked the team for their efforts at North Hills CC. The WSGA won the matches 47-41.

Scholarship: Joe Stadler announced the winners of the 2021 PGA of America scholarships.

Jeff Ellingson announced that Matt Taken was elected Secretary, Mark Voeller as VP and Mike O'Reilly as President at the board meeting earlier in the day.

GOVERNANCE UPDATE

As most are aware, there are some significant changes for the 2022 season regarding the PGA Professional Championship and the NCR Assistant Professional Championship, suggested by the Tournament Committee and approved by the PGA Board of Directors. Below are the two major changes:

- Life Member Active Eligibility for the PGA Professional Championship The Life Member Active (LMA) and Life Member Master Professional Active (LMMA) classifications are no longer eligible classifications for the PGA Professional Championship. This makes the PGA Professional Championship solely for PGA Professionals in an actively working classification (LMA and LMMA will remain an eligible classification for the Senior PGA Professional Championship).
- NCR Assistant Professional Championship Eligibility Only A-8 and B-8 classifications are eligible to advance to the national event.

As a reminder, these changes will start with the 2022 Section Championships that advance players into the 2022 NCR Assistant PGA Professional Championship and into the 2023 PGA Professional Championship. These changes do not affect the eligibility of players in the 2022 PGA Professional Championship. Below provides the perspective of the Tournament Committee and the Board for these two changes:

Life Member Active Eligibility for Member Championship

The PGA Tournament Committee vetted this for the past year when reviewing eligibility guidelines for the PGA Professional Championship.

- The Committee felt strongly that the PGA Professional Championship is for working PGA Professionals in an active classification. Reverting back to the standards in place prior to 2006 when Life Members were not eligible for the PGA Professional Championship was determined to be the best way to align with the Committee's perspective; however, Life Members will remain eligible for the Senior PGA Professional Championship.
- The PGA Professional Championship is a showcase for those Members who can work in an eligible classification and maintain playing at a high level.
- A Life Member has the opportunity to transfer into an active classification that is eligible for the PGA Professional Championship.

NCR Assistant Professional Championship Eligibility Change Where Only A-8 and B-8 classifications are eligible to advance to the National Championship.

• The Championship has the name "Assistant Professional". The intent of the Championship is for those Members and Associates (A-8 and B-8) that are working as Assistant Professionals.

- The venue will host championships operated by the PGA of America, including the PGA Championship, KPMG Women's PGA Championship, KitchenAid Senior PGA Championship and PGA Professional Championship. A future Ryder Cup is also a possibility.
- Being part of the No. 5 media market in Dallas an area that is incredibly passionate about golf–brings many benefits. From attracting and retaining a diverse talent pool to new championship and education facilities, this relocation will drive continued growth.
- The PGA's Northern Texas Section also plans to be located on the campus. With better connectivity between Sections through embedded state-of-the-art technology, there will be promising opportunities to pilot new programming for all 41 Sections of the PGA of America.

This report contains information about the Junior Foundation Board, Event updates & Memberships.

Board & Event Updates

The Junior Foundation board elected a new President in fall of 2021. Ed Elsner has stepped down as the President. We would like to thank him for his years on the board and his promotion of junior golf. Michael Bielawski was elected as the new President along with, Lindsay Koth- Vice President and Jeff Ellingson, PGA as Secretary. Other board members include, Derek Schnarr, PGA, Katie Elliott-Johnson, Dan Hoffman, PGA, Eric Holen, Garrett Jones, Brad Munn, PGA, Brandy Johnston, Kim Dodd, Kevin Van Rossum, Steve Bailey and Mike Wilson.

The Junior Foundation is excited to have a few new events on the schedule. Our schedule includes over 130 junior events throughout the summer for juniors all ages and abilities. Thank you to our sponsors (Balance & Believe Foundation, Culver's, Middleton Ford, Bridgestone Golf, Shattuck St. Mary's School, Morgan Stanley, WSGA, X Golf Brookfield/Mequon, X Golf Madison/Middleton).

New in 2022

- Our scholarship applications will now all be done online, it opened on February 8th. Our scholarship deadline is April 29. We awarded over \$50,000 in 2021 and will look to increase that number in 2022. Visit our website for more information.
- We have added an Intermediate Tour in 2022. This tour is geared towards juniors who have aged out of the Future Tour (playing 9-holes) but are not quite ready for the Junior Tour (18-hole events for skilled players) and for those 10-12 year old's who want to try and play in an 18-hole tournament. This tour will play shorter yardages and we will modify tees so the Boys 14-15 will play from about 5,700 to 5,900 yards and younger boys and all girls will play around 5,000 or less yards. This tour is geared for players under the age of 15.

We will continue to offer a Beginner 11 & under membership for juniors. This gives them benefits and discounts to Par 3, Future Tour and X Golf events for a fraction of the regular Junior Membership fee. The cost is \$29 for the Beginner 11 & under Membership. If the junior participates on a PGA JR League team they will receive a discount code for \$29 making the Beginner Membership FREE for them.

- Women's State Open June 14-16 hosted by Lawsonia Links
- Assistants Championship July 18 hosted by Wausau CC
- Senior Championship July 18-19 hosted by Wausau CC
- State Open August 15-17 hosted by Ozaukee CC
- Senior Open September 6-7 hosted by Hidden Glen GC
- Section Championship September 12-13 hosted by The Legend at Bergamont

Tournament Pricing – The TPB approved a \$5 increase to entry fees to cover an increase in food costs for the pro-pros. The pro-ladies, pro-scratch and super-pro will see at least a \$5 increase per player. The WPGA staff will review those particular events and determine the best course of action.

In regard to 4-player pro-ams, the TPB concluded that prices should go up by more than \$5 per player. The idea of offering three different entry fee price points was endorsed. After staff review the price points will be \$480, \$600 and \$800. The staff will create a structure that has different club fees paid based on the entry fee.

A unanimous vote concluded that the \$10 skin game will be included in the WPGA Classis pricing going forward.

State Opens

- Based on comments from the TPB and survey results it was determined that the two-course State
 Open/expanded field would make occasional appearances in the future when a primary and secondary site
 make sense. The State Open will stay a 3-day, 72 hole event.
- The TPB would like to continue to show their appreciation to Vince Suter for his continued sponsorship of the State Open!
- The Women's State Open will attempt a three-day event this year including a cut after 36 holes.

Las Vegas pro-am – A lengthy discussion on several aspects of the registration system was had. The general consensus from the group was to survey the Membership to try to get an idea of actual interest and also create a proposal for a lottery system for the priority spots. The proposed lottery system will be sent to several professionals that have supported the trip on a consistent basis. The results will be utilized to gauge whether we attempt a fall trip or possibly look at reconfiguring the 2023 spring trip.

Professional Championships – The PGA of America has turned over the entry processing for the Professional Championships to the sections. Registration deadlines for the three Professional Championships will move to one week prior to the event. The eligibility guidelines for our Assistants Championship will not change, all associates will continue to be allowed to play. It was decided that the A-8's and B-8's that advance to the national event will be able to earn Player of the Year points at that event.

Amateur Status Rules – We currently are paying cash for skins to amateurs at The Legend Challenge, Super-Pro and Senior Open (if they choose). All other events are shop credit. The WPGA will continue to payout shop credit when it comes to individual and team prizes. The only exception will be the skins games at the aforementioned events.

Pro-am Registration – The demand for events is exceeding capacity and events are selling out in a matter of weeks/months ahead of the actual event. Professionals are having to outlay significant funds up front to get registered. As a result, in 2022, a staggered registration opening for pro-ams was approved. We will try this method for 2022 and review in the winter. The section staff will setup monthly email registration opening reminders to our amateur participants and professionals.

Match Play Seedings – All Match Play events will require players to qualify. No seeds will be awarded based on the prior year's performance.

Player Development Report - 2022 Spring Meeting

Current Focus -Our Player Development Committee is being revamped to include two sub-committees – one focusing on Junior Player Development efforts and the other on Adult Player Development programming to mimic the PGA of America national Committees. Both PGA Coach and Family Cup will have their own pages on our Section website. Other areas of focus include publishing best practices on our website and updating our mission statement.

Family Cup – 2022 marks the first year the WPGA will market and promote Family Cup. A PGA Family Cup is a facility event similar to PGA Jr. League but with family teams of 2-6 players. PGA Professionals have the opportunity to host an event based on their own schedules, collect fees and order team kits in the same fashion as PGA Jr. League.

Why host PGA Family Cup? Build the PGA brand while hosting multi-generational teams – you can choose a variety of formats and give your PGA Jr. League parents, grandparents and other spectators a reason to play at your club! In 2021, a PGA Family Cup event averaged **nearly 3.5 times above** the facility's average Sunday revenue.

PGA.Coach - The WPGA ranks 19/41 Sections in terms of ADM certified / professionals compared to the size of the membership. Southern California has the most certified at 253 while we are in the middle with 89 total.

PGA HOPE -There are PGA HOPE training sessions scheduled in nearby Sections- Minnesota (Bunker Hills on 3/21) and Gateway (Sunset Hills CC on 3/30). Wisconsin is set to have another training session in 2023. If you need assistance with marketing materials for your program, please reach out the Section office. There is a dedicated space on our website to promote your program.

PGA Jr. League Update- Coach registration ends on April 1st, and no that is not an April Fool's joke. Coaches are enjoying the ease of the new tech platform where PGA Family Cup, PGA Jr. League and PGA Coach are housed in one location; paired with the improved mobile app. We hosted a webinar highlighting my.pga.com and the recording is posted on our Section websites member only page.

Registration numbers continue to climb while three new facilities hosting programs in 2022. Year-to-date we are 30% ahead of our best year – 2019 (1289 total player registrations). Most of the sign ups occur in February, March and April. PGA Jr. League members are eligible for a WPGA Jr. Foundation membership at a discounted rate. Coaches communicate this discount code directly to their players.

Drive, Chip and Putt Update The schedule of qualifying sites is posted on www.drivechipandputt.com. Registrations began on January 25th, and Wisconsin is hosting 12 local qualifiers. Registration numbers are similar to 2021 thus far. Erin Hills and The Legend at Merrill Hills current have over 100 participants registered.

Wisconsin has one National Finalist, Cody Guetzke, competing at the Championship on April 3rd, 2022 – the Sunday prior to the start of the Masters Tournament. He will compete in the Boys 14-15 year old age division. We know he'll represent Wisconsin well!
