# Wisconsin PGA Membership Meeting Minutes Monday, March 6, 2022 Wilderness Resort – Wisconsin Dells

Meeting called to order at 12:02pm.

Mike O'Reilly thanked Mike Warren who completed 10 years as the president of the Wisconsin Golf Sales Association. He then introduced the new president, Jim Gaugert. Mr. Warren and Mr. Gaugert addressed the membership and thanked them for their support.

#### Report of Matt Taken PGA – WPGA Secretary

Mr. Taken gave an overview of the secretary's report including new members, quarter century members, newly certified/specialized.

#### Report of Mark Voeller, PGA - WPGA Vice President

Mr. Voeller provided an update of the WPGA financials for the end of January. He thanked the past boards and past presidents for all their work to have the WPGA in the financial position it is in. He commented on investments and that we are certainly keeping an eye on the future and the apparent decline happening.

#### Report of Mike O'Reilly, PGA- WPGA President

Mr. O'Reilly introduced the WPGA's two new staff members - Jazz Tulda, Junior Tournament Manager and Amelia DeCeanne, PGA WORKS Fellow. Mike then gave an overview of the Super Regional the officers recently attended. He shared his thoughts on the 3 candidates for PGA Secretary and reviewed the process. Mr. O'Reilly then provided an update of the 100 years of the WPGA and the plans for a 100-hole event to raise funds for charity. He also showed a video created by Scott Walecki highlighting the 100 years. Mike then provided an update on the marketing efforts with Nelson Schmidt and O'Reilly PR. We are currently focusing on employment/work/careers with a smaller focus on indoor winter golf or places to play/practice in the offseason. Mike then provided a brief update on the industry from 2021 and a look into 2022.

## District 6 Director - Rob Elliott, PGA

Rob Elliott, the District 6 Director provided an update on some national items. A video was shown on the new homesite at Frisco. Sagacity, the national assistant's championship, PGA members attending the Masters, PGA Hope/Patriot Golf Day were Rob's other topics.

#### Report of Joe Stadler, PGA - WPGA Executive Director

Mr. Stadler provided a sponsorship update for the Section and Foundation. He explained the American Family Insurance Championship Charity Challenge which is back in 2022. He also mentioned that we will again be offering some of our members the opportunity to volunteer for the American Family Insurance Championship.

# Report of Joe Stadler, PGA – WPGA Junior Foundation

Mr. Stadler introduced the new officers and board members to the foundation. Mike Bielawski, President/Lindsay Koth, VP/Jeff Ellingson, Secretary/Steve Bailey, Marquette coach/Mike Wilson, UW coach. Stadler mentioned the creation of

the new intermediate tour. He mentioned the membership and that we could end up with about 1,330 members at year end. The expectation is to provide \$60,000 in scholarships in 2022. Registration for tournaments begins on March 31 when we will take in 33% of our annual revenue in 12 hours. He mentioned that Nora Roberts and Kaeden Nomm will be honored as the 2021 players of the year.

## **Report of the Committees:**

**Tournament Policy Board:** Matt Taken thanked all the host facilities. He explained a few changes for 2022 including: some pricing increases due to food cost increases, skins included in some events and almost all will be paid in advance, the large state open field will occur but not on an ongoing basis, the women's open will be 54-holes with a 36-hole cut, Las Vegas Pro-am – how to accommodate everyone's interest is a huge topic, all national entries will go through the section, pro-am registration will be changed to a month by month opening for registrations and a lottery may be introduced for some events,

**Education:** Danny Rainbow reminded everyone that the MSR cycle ends on June 15. He provided the highlights of the winter virtual seminar series. He mentioned the breakout sessions following the meeting by GolfTec, the table show and PGA Family Cup with Frank Chieppa. The annual teaching seminar will be held at University Ridge during the AmFam Champ on June 7. GolfTEC and Brendan Locke have stepped up to sponsor the event for the next 6 years.

**Membership:** Mark Voeller mentioned the mission of the PGA of America and touched on the new deferred compensation plan that is rolling out in 2023 and the new license plate design that Andy Landenberger was able to get approved by the DOT.

**Employment:** Mike O'Reilly introduced our new career consultant, Ryan Holland. Ryan Holland introduced himself and stated his number one priority is compensation. He then mentioned the compensation profile and how important it is to compensation. Wisconsin ranks 8<sup>th</sup> in member participation. He then mentioned the job seeker profile and encouraged everyone to update their profile. Finally, he reviewed the ExecuSearch process.

**Player Development:** Scott Walecki mentioned the different areas that player development encompasses. He is going to split the committee in two areas: youth and adult. There will be a focus on best practices. A video was shown on ADM/Jr League and how to incorporate training into golf. The committee is going to focus more on PGA Hope. Scott also touched on DCP and shared the 12 local qualifier list.

**Assistants:** Shaun Finley mentioned the committee had a positive meeting to discuss ideas. A survey will be sent to associates soon to help prioritize the work of the committee. Shaun mentioned the IronWorks scholarship, the PAT list and he lastly encouraged everyone to get involved.

**Special Awards:** Mr. Ellingson mentioned the evening reception to honor the winners of the awards and the players of the year. He mentioned that the committee met in person this year before finalizing awards. He introduced the winners and then thanked the committee and sub-committee for their efforts.

Nelthorpe: Mr. Ellingson introduced the 2022 team that will compete at Meadowbrook CC.

**Scholarship**: Mr. Stadler provided a brief overview of the PGA scholarship program.

# **Executive Director Report – 2022 Fall Meeting**

I haven't missed too many spring or fall meetings in the past 30 years but unfortunately, I will be unable to attend this one. I am wrapping up a 2-year term a chair of the Executive Directors Committee and a six-year run of being on the committee. It has been a great two years being more involved with the governance of the PGA and how the PGA supports sections. It was interesting to be able to attend PGA of America board of directors' meetings and provide insight into how sections operate and the ramifications of decisions. A huge thank you to Jim Richerson for inviting me to chair the committee and to our officers for allowing me the time to do so.

A big thank you to all our sponsors and supporters. Between section and national sponsors, the support of the section has almost doubled in the past 10 years. Anything you can do to thank them goes a long way to renewing agreements each year. A special thank you to our largest supporters: PGA Tour, Suter Ward Group at Morgan Stanley, American Family Insurance Championship and the Balance & Believe Foundation.

The section and foundation had another great year. The events and seminars were well attended for the most part. The TPB continues to look at options to improve events and add new ones as needed. The various committees are making efforts to improve the role of the WPGA and to add value to our membership. The marketing and public relations campaigns continue to showcase the PGA member and their value to the public, their members, and their employers. We are trying to create awareness of the business of golf and the career paths available to help make your life easier in finding employees. There is no magic bullet for this one, unfortunately. The foundation is continuing to grow. We offered over 150 events this year. We provided \$60,000 in scholarships, as we are approaching a half million dollars since the program was started in 2000 with one \$1,000 scholarship. Thank you to all our host facilities and professionals for everything they do to make all this possible.

An area of consternation for some of us was the lottery system put in place for this years' Las Vegas Pro-am. If you have not heard, a major reason the lottery was put in place was to try to determine just how much demand was available for the event. We had no way of knowing in the past. This year we had 76 teams sign up for the lottery. So far, 7 of those teams selected did not have teams ready to register so our true demand is somewhere between 60-68 teams. The TPB will be looking at options to create more space to add teams in 2024 so we can accommodate everyone interested in playing in Las Vegas. Everyone may not be in the same event at the same time, but we will do our best to make sure we expand availability.

A thank you to the staff at the Wisconsin PGA. I hear from so many of my colleagues that they struggle to attract and maintain talent and we are blessed not to be in that situation. Andy Landenberger started with us in 2003 and will be completing 20 years next spring. Chris Hoel then joined us in May of 2005 and is in his 18<sup>th</sup> year. Believe it or not, Erika Pirkl is already finishing up her 7<sup>th</sup> season. Jazz Tulda is completing his first year with the section and Amelia DeCeanne is completing her one-year Fellowship. Without their dedication, knowledge, experience, and passion the WPGA and the WPGA Junior Foundation would not be where it is today as a leading section in the country.

Last, thank you to all of you, the PGA members. Without you, there is no Wisconsin PGA and golf in Wisconsin would not be the same. Keep up the great work and do what you can to find time this winter to reenergize and be ready for 2023. See you next spring.





# Wisconsin PGA Section celebrating 100th anniversary

In 1922, **Walter Hagen** became the first American-born winner of the British Open, Pioneering African-American golfer **Charles Sifford** was born that year, and **Bobby Jones** was one year away from embarking on one of the greatest major championship runs in golf history.

And in Wisconsin, a group of professional golfers established the Wisconsin Section of the PGA of America. The WPGA is celebrating its 100th anniversary this year, as are the Michigan and Pacific Northwest sections. Only four others have reached this milestone; the Metropolitan and New England sections, established in 1916, and the Philadelphia and Illinois sections, established in 1921.





# Wisconsin PGA Members celebrate Section's centennial with 100 Holes for 100 Years fundraising campaign

hig milestone calls for a big celebration. That's exactly what is transpiring this summer throughout the Wisconsin PGA Section, where PGA Members from across the state are taking part in the 100 Holes for 100 Years campaign. The fundraiser is anchored by Wisconsin PGA Professionals playing 100 holes in whatever way they choose in the event's 100-day timeframe (May 2–Aug. 9), raising donations for a charity of their choice and PGA REACH Wisconsin, the Section's foundation.

As of mid-July, nearly \$40,000 dollars had been

raised through the 100 Holes for 100 Years campaign, with solo PGA Professionals and teams from Kohler Co. and GOLFTEC all contributing.

"The opportunity to do something like this together, playing the game we love while supporting a good cause, is a great experience for all of us," says Mike O'Reilly, the PGA Director of Golf & Retail for Destination Kohler in Kohler, Wisconsin, who joined other Kohler golf staff in a 100-hole marathon across Whistling Straits and Blackwolf Run. "We will have so many Section Professionals involved, spread across the entire

state, supporting different charities. The impact will be widespread both inside and outside the golf community."

So far, different highlights have been pouring in.
Erika Pirkl, the Section's PGA Director of Player
Development, completed a nine-hour and 18minute 100-hole round at Naga-Waukee War
Memorial Golf Course in Delafield on July 5,
supporting PGA REACH Wisconsin and the Rogers
Behavioral Health Foundation. She even capped
off her round with a birdie.

"We wanted to get creative," says Pirkl. "It's the centennial of the Wisconsin PGA. I've been fortunate enough to call this place home for so long, but it's more than that, right? It's more than teeing it up for 100 holes."

Hanc Spivey, the first Black Wisconsin PGA Professional, was not only celebrating 100 years of his Section, but a special PGA membership milestone, too.

"It marks my 30th years as a PGA Member, so it was an easy decision for me," says Spivey, a PGA Life Member who was the longtime PGA Head Professional at Dretzka Park in Milwaukee. "I played 100 holes over six days and my best friend, Mark Hansen, played 18 with me – we laughed about seniors playing 100 holes in a day."

Up in Wisconsin's Northwoods, Dave Kemnitz was having an equally enjoyable time — especially after acing the 13th hole of Minocqua Country Club, where he serves as PGA Head Professional, in his fourth round on the way to 100 holes.

"My favorite part was having my wife and 8-year-old son Noah join me for the last six holes," says Kemnitz, who with the help of the Minocqua Country Club membership raised close to \$13,000 for PGA REACH Wisconsin and the local hospice in Minocqua. "Noah caddied and guided me to the finish line, which was awesome. Hopefully, this campaign will continue the growth of the game through PGA REACH and create those wonderful experiences for somebody else, just like I've been lucky to have."

Beyond that foundational principle, it would be inappropriate and premature for us to speculate on what may or may not happen in the future."

2023 PGA Championship – "There will no doubt be a lot that unfolds before May of next year. It would be inappropriate and premature for the PGA of America to speculate at this time."

Member Benefits Programs – We are looking to Vet and enhance health benefits/offerings. We are continuing to explore deferred compensation (Current fiscal challenges may hinder implementation in the near term). We continue to seek out new opportunities.

Finally, we will be electing a new Secretary of the PGA on Thursday. Nathan Charnes, PGA is the General Manager at WingHaven Country Club in O'Fallon, MO. He will be elected and sworn in. Nathan will be a great addition to the Executive Committee as he joins Don Rea – Vice President and John Lindert – President. Jim Richerson will now become the Past President. # **WPGA Junior Foundation Report – 2022 Fall Meeting**



The Junior Foundation had tremendous growth in 2022 with entries and memberships.



The junior memberships were back up 4% from last year and ended up with 1,338. We had our biggest increase with tournament entries, which were up 12% from last year totaling 8,731. Entries were up 938 from last year. We added several more events this year and included an Intermediate Tour in 2022. The Future Tour had a decrease this summer for the first time in years. The 9-hole events for juniors to get tournament experience averaged 34 players per event versus 48 players in 2021. This tour is our feeder program for Junior Tour. The X Golf County Parks Series based around MKE county parks courses had the biggest increase in 2022. These events averaged 92 players compared to 75 in 2021. Our Junior Championship had 341 players, up from 323 in 2021. The event has been held at Brown Deer Park and Dretzka Park the past ten years. The Junior Championship winners were Jessica Guiser of Hartland and Sebastian Kasun of Elm Grove.

#### Players of The Year

Norah Roberts of Racine is our Girls Player of the Year. She compiled 2,205 points. Norah is a junior from Racine. She won our Junior Girls Match Play and Sherri Steinhauer events. William Harned from Nashotah captured the Boys Player of the Year in a close race with Rasmus Madsen and Mason Schmidtke. Will won the WSGA Boys State Junior event and then went onto finish 2<sup>nd</sup> at the Mike Schnarr Boys Championship to hold onto the title.

#### **Cup Matches**

The 25<sup>th</sup> Annual Wisconsin/Minnesota Cup Matches were hosted by La Crosse CC. The event was held on June 29-30. This event pairs a team of 12 boys and 12 girls from Wisconsin against Minnesota in a Ryder Cup team-type event. Team MN led 7 to 5 after day one of four ball matches. Team Minnesota held onto win 14 points in singles matches to keep the cup for the seventh consecutive year. The final point total was 21 to 15. The overall series is now tied at 12-12-1.

#### **Junior Foundation Scholarship**

The foundation awarded 31 scholarships totaling \$50,000. College scholarships included Alyssa Schmidt \$1,250, Logan Pechinski \$1,250, Lily Sheppard \$1,250, Megan Bonikowske \$750. Our High School Scholarships were Will Summers \$1,500, Taryn Endres \$1,500, Max Reis \$1,250, Michael Antonelli \$1,250, Sam Hurley \$1,250, Noah Gage \$1,250, Jenna Anderson \$1,250, Claire Kelbel \$750, Jakson Jazgar \$750, Griffin Oberneder \$750, Ben Hilbelink \$750, Ethan Thomas \$750, Jacob Frederickson \$750.

The Tony Coleman Memorial Scholarship for \$1,750 was awarded to Joey Drana of Muskego and Nora Purtell of Brookfield. Sarah Balding of Brookfield, Adam Baumann of Marinette, Addison Raimer of West Bend and Reagan Stuke of Delafield all received the Terri Noel Scholarship at \$2,500 each.

Brendan Lemery of Grand Chute was awarded the Kevin Dunn Memorial Scholarship for \$1,500. Kaeden Nomm of Minocqua was awarded the Marty Swab Kid to Kid Scholarship for \$1,750. Noah Kirsch of Lancaster was awarded the Wisconsin Golf Salesperson's Scholarship for \$1,750. Carly Lois of Burlington was awarded a new scholarship in 2022, the Warren Family Scholarship for \$1,750.

Balance & Believe Scholarships were given to Eva Kumer of Brookfield and Nolan Thompson of Menomonee Falls. Each of them received a \$2,500 scholarship.

The WPGA Junior Foundation has teamed up with the American Family Insurance Championship to continue offer two scholarships. One boy and one girl each received a \$3,250 scholarship. This is our highest scholarship amount given out. Girls Winner – Emily Hopp of Oregon. Boys Winner – Hunter Neumann of Warrens.

# **Employment Report – 2022 Fall Meeting**

On a national perspective from the Career Services team, there was a lot of movement in 'opposite season' markets, with Florida, South Texas and Arizona seeing a tremendous number of job openings and PGA ExecuSearch postings. There are a number of reasons for these positions becoming available, and we do expect a busy off-season in the same regard here in Wisconsin and the upper Midwest. The PGA.org job board is already heating up, with 12 positions currently posted (there were just 4 as of one month ago. We have 2 PGA ExecuSearch Advanced Searches currently in progress with the Head Professional positions at Eau Claire Golf & Country Club and the Wisconsin Club.

Interactions with our Career Consultant and the Career Services team have increased tremendously year over year. In the past 90 days, there have been 278 total interactions with Wisconsin PGA Members and Associate professionals (a 291% increase from the same period in 2021), occurring with 209 unique Members and Associates (a 386% increase from last year).

Completion of the compensation profile continues to be a point of emphasis for all of the Career Consultants across the country. The Wisconsin Section currently ranks 4th amongst the 41 Sections in completion rate, with 67.4% of active members taking part. This shows the Section is leading the way, but there are still 137 who have not taken part. This data is crucial to the Section Comp report and ability to create custom compensation reports. While the comp tool is no longer available on PGA.org, you can reach out to Ryan at any time for a custom report for your position or your facility. Across the country, the Career Services team has helped PGA Members negotiate compensation increases of over \$1.2 Million Dollars year-to-date using this data and the resulting reports, with several examples here in the Wisconsin Section. These increases are current position re-negotiations, not new hires. Please continue to spread the word on the importance of providing this data to your peers, and reach out to our Career Consultant Ryan Holland, PGA today to discuss further and request your custom report.

# PGA PROFESSIONAL DEVELOPMENT REQUIREMENT

**EFFECTIVE FOR CYCLE 17 - June 16, 2022 - June 15, 2025** 

#### PROFESSIONAL DEVELOPMENT REQUIREMENT POLICY, (PDR), as defined by the PGA Board of Directors:

- 1 A Section may require that all Section and Chapter activities be approved in advance.
- 2 Based on previously approved activities, established guidelines and Section recommendations, the National Office will approve the credits to be awarded for a certain activity. The Board of Control will determine the number of credits in all disputes and the Board of Directors reserves the right to make modifications to the requirements.
- 3 A participant may receive compensation for an activity.
- 4 Fifty-four (54) Total credits are required for a three-year cycle; of which at least 30 must come from Education and/or Specified Player Engagement Programs and six (6) must come from Meetings and/or National Survey Submission.
- 5 Members who have attained a combination of years of membership and age which adds up to 90 or more before the start of the Professional Development Requirement Program Cycle (June 16, 2022), shall be required to earn 12 PDR credits only from any PDR category.
- 6 Members in the Unaffiliated Section will be required to earn two thirds (2/3) of the requirement.
- 7 Members in the Reserve Classification will be required to earn one half (1/2) of the requirement.

# <u>30 Required Credits</u> - PGA Approved Education, Professional Standards Education/Training and Specified PGA Player Engagement Programs:

- Attending career specific education, including serving as a speaker/instructor. Attending education on topics such as youth safety, diversity, equity and inclusion, mental health wellbeing. 1 credit per each hour of attendance.
- It is recommended that education be completed within one's current, or desired career path (Executive Management, Golf Operations, or Teaching and Coaching)
- Any online education must have an assessment which is successfully completed.
- Specified Player Engagement Programs Credited Per Below
- PGA HOPE Clinics (1 credit for hour or each hour of participation, up to six credits per PDR cycle year
- PGA Junior League (6 credits per team/season, maximum of two PGA Members earning credit per team/season, up to twelve credits per PDR cycle year
- PGA Family Cup (6 credits per team/season, maximum of two PGA Members earning credit per team/season, up to twelve credits per PDR cycle year
- PGA Junior Camps (2 credits per camp week, up to six credits per PDR cycle year)
- Drive Chip & Putt Host PGA Professional 4 PGA Required PDR credits. Other PGA
   Professionals participating/volunteering 2 PGA Required PDR credits for five to eight hours
   participation, 1 PGA Required credit for four hours participation, up to eight credits per PDR
   cycle year.

#### 6 Required Credits - PGA Meeting Attendance and National Survey Completion:

- Attending National, Section or Chapter Meetings, including Board and Committee Meetings 1 credit per each hour of attendance. (If a meeting is offered both in-person and virtual, in-person attendees will receive full credit, while virtual attendees will receive half (1/2) credit.
- Completing National Surveys (such as: Compensation Survey, Annual Operations Survey, Member Offering Survey, Career Planning Survey, Revenue Scorecard) – max 2 credits per National survey, per cycle year

### <u>54 Total Credits</u> - Credits Toward the Total Requirement:

- Serving the Section, Chapter, National PGA or Allied Association. Participating in advancement
  of the game activities such as radio shows, TV shows, speeches, golf promotional non-playing
  events, golf clinics and other volunteer activities, such as non-playing tournament official.
   Section Surveys. (1 credit per hour of participation with a maximum of 8 credits per day)
- Serving as a golf coach or assistant golf coach of a high school/college golf team in a capacity not considered the Member's primary employment. (Maximum of 6 credits per PDR cycle year)
- Participation in Section sanctioned golf tournaments or tournaments conducted by the PGA of America National Office. (2 credits per Section event. 4 credits per National event)
- Attending a National, Section or Allied Association Merchandise Show. (Maximum of 8 credits per PDR cycle year. 2 credits per show)
- PGA approved news, media, and magazine articles or published book. (Maximum of 4 credits per PDR cycle year. 1 credit per article)
- PGA National Club Championship 1 credit per year for submitting the Club Champion.
- High School Seminars 2 credits for participating
- NCCGA Event Host 2 credits for hosting
- NCCGA Coach 6 credits for coaching per season
- City Tour 2 credits for hosting

The PDR Cycle is from June 16, 2022 through June 15, 2025. Where credits are restricted per cycle year, the PDR Cycle Year is defined as June 16<sup>th</sup> of one year to June 15<sup>th</sup> of the next year.

- 1) <u>Total Credits (54)</u> A total of 54 credits must be earned, with at least 30 credits from Required Education Credits/Specified Player Engagement Programs and at least 6 credits from the Required Meeting/National Surveys Credits, while the other means of obtaining credits toward the total requirement remain per the prior program.
- 30 Required Credits PGA Approved Education, Professional Standards Education/Training and/or Specified PGA Player Engagement Programs
- 3) 6 Required Credits PGA Meeting Attendance and/or National Survey Completion
  - All credits earned in the Required Category are also credited toward the Total Category.

# Membership Committee Report - 2022 Fall Meeting

**Mission:** To ensure that all WPGA members and associates have the opportunity to benefit, both personally and professionally, from their PGA membership. The committee will work to create, enhance and communicate all appropriate PGA of America and Wisconsin PGA benefits.

#### Seth Waugh, CEO of the PGA of America at PGA of America Annual Meeting November 2021

"The last subject I want to talk about, and most importantly, is something we've discussed a lot this week. We've gone from a demand problem in terms of players to a supply problem. The lack of supply is hours in the day, lack of balance in our members' lives and a lack of pipeline of talent to replace our aging population...virtually everyone has been asked to raise the bar, to do more with the same, to work insane hours. It's absolutely unsustainable, and there's a crisis brewing for facilities that don't get in front of it. They simply won't be able to deliver the same level of service in the short-term, much less attract the next generation of talent. We have to shout this message from the rooftops, change the dynamic and restore work-life balance."

Based on the opening statements from the article below from Golf Digest this summer, titled "The Club Pro Crisis," it appears that the crisis is not brewing, it is here.

Thanks to his connections, Casey Kermes had forged what looked like the start of a brilliant career. After hurting his back playing college lacrosse, he joined the Professional Golf Management (PGM) program, landed his first internship in Ireland and spent the first four years of his post-college career bouncing between some of the most prominent courses in America as a seasonal assistant pro. Frequent travel was an expectation for ambitious assistants, but money was a problem-he wasn't even making enough to rent a shared apartment and would often stay in the spare bedroom of the head pro. As his breaking point, he landed a job as a full-time assistant in North Carolina, with the promise he'd spend most of his time teaching. Instead, when he left the clubhouse at all, he found himself babysitting large groups of kids who didn't want to be there any more than he did.

At 26, he took stock of his career. He felt like "a glorified McDonald's checkout person," his golf game was dismal-he had played just five full rounds in two years-and he was working anywhere from 60 to 90 hours per week depending on the season. The concept of having a normal romantic relationship, much less a wife and kids, was a joke. And dealing with members could be a nightmare; he vividly remembers the day when he told a board member that her foursome couldn't start on the second hole, and she chewed him out and did it anyway. There was another board member in the group she skipped, and he marched into the golf shop to yell at Casey for letting it happen. Both members, incidentally, were millionaires. Casey was making \$30,000.

He knew the pay would go up when he became a head pro, but from what he could see, nothing would change. He couldn't stop thinking of a head pro in the south, his one-time boss, who would get free NFL tickets from a member but would feel too guilty and too afraid to take his son to the game and miss a Sunday at work.

"I was at the tipping point where you go from a seasonal assistant to full-time assistant to head pro," Kermes said. "And I was looking at those jobs and thought, 'I don't actually want to do that. It still sucks. When does this not suck?' And I could never figure out when that was."

He quit before his 27th birthday. His only regret now is that he waited so long.

## Dan Pasternick, candidate for PGA of America Secretary, 2022

WHY I AM RUNNING: Two years ago, I was sitting in the back of the room at the New Jersey PGA Annual Meeting. My good friend, David Reasoner, a PGA Professional whom I respect and admire, was presiding. David was finishing his second year as the NJPGA President, and on the way out, as only David can, he dropped a bomb. He asked the crowd of PGA Members in the room, "By show of hands, how many of you want your son or daughter to become a PGA Member?" Not one hand went up. David knew the result his provocative question would elicit, but he asked it to make a point.

\*\*\*\*\*\*\*

I became a member of the PGA of America for one simple reason, it gave me the most opportunity to play tournament golf for money. When my collegiate golf career was coming to a close, I would play in many Chippewa Valley Golf Association tournaments. Players could transfer winnings from other courses to Eau Claire Country Club. At the end of the year, they had a Tournament of Champions at the Country Club. After putting a few dozen balls and a shirt on the counter, I looked around and was thinking what else do I need? So, I gathered up about 20 pairs of socks and declared: "I am done playing for socks." The next spring, I checked the professional box on my US Open entry blank, yes, back then it was on paper, lol.

At that point, I did not know if I would get into the golf business or become a member of the PGA of America, but I knew I wanted to play tournament golf for cash. I do truly believe the WPGA, and the PGA of America has given me much more than the mere opportunity to continue playing tournament golf, but it is still the biggest reason I renew my membership each year.

So, what is your why? Is it playing in tournaments like me? Is it the feeling of fraternity and family as Past President Jeff Ellingson has stated many times in this meeting and in the boardroom? Or is it something else?

All of you are immensely talented, you could have made a bunch of money and been successful in any career you chose, so why golf?

Maybe it is time we start not asking what the PGA of America and the WPGA can do for us, but rather what we can do for the PGA of America, the WPGA and most importantly, the game of golf.

# Player Development Report - 2022 Fall Meeting

**Mission Statement:** It is the goal of the Player Development Committee to aid the member of the Wisconsin PGA Section in their Player Development efforts while serving as consultants and providing guidance regarding growth of the game programs. In addition, the committee will serve as advocates of the PGA Jr. League, Drive, Chip and Putt, and other player development programming within their designated region.

## **PGA Jr. League Update:**

- 1294 players registered 96 WPGA affiliates coached 102 programs. Most players registered in a season to date. Sounds great on paper but we rank 25<sup>th</sup> out of 41 sections for registered players.
- Biggest area of concern is the decrease in private clubs engaging with the program and Wisconsin ranking 38<sup>th</sup> out of 41 Sections for coaching fee (fees paid to the PGA Professional beyond the Gamechanger fee of \$99).
  - o Wisconsin averaged \$172, while the highest ranked Sections surpassed \$310. Average is \$233.
- The South Central All Star team coached by Travis Becker, PGA won our Section Championship and competed in the Midwest Regional where they finished in 3<sup>rd</sup> place. The Lake Windsor 17u team competed in the same Regional and came out with a victory captained by PGA Associate Jordan Ray. At the Midwest Regional, Jeremy Cabalka, PGA coached his team to victory for the second consecutive year. Congratulations and thank you to Hidden Glen at Bentdale Farms, Lake Arrowhead and Blackhawk CC for hosting our All Star season.

## **Drive Chip and Putt Update:**

- We continued our hybrid model for our 12 local qualifiers. 5 of the qualifiers were executed by the Section staff, while 7 were administered by our WPGA members at their facilities with the help of Section staff.
- 1355 juniors registered in 2022 for a local qualifier averaging 112 per event.
- 2023 will be similar, with 12 local qualifiers and 2 sub-regionals. We are on track to meet our goal of a 3:12 ratio for local qualifiers whereas the Section staff is on site for the three locals in the largest markets.
- The 2023-24 schedule is complete with registration officially opening in January on www.drivechipandputt.com
- Wisconsin produced two 2023 National Finalists Adalyn Lupton of Waunakee and Alex Kim of Elm Grove.
- Thank you to our WPGA professionals who plan to host a qualifier or sub-regional once again!

#### Pathways:
